NOTICE OF ALTERATION OF ALDERMANIC DISTRICTS

PLEASE TAKE NOTICE, that a Public Hearing will be conducted by the Common Council **via Zoom Teleconference/video Conference** on Thursday, October 28, 2021, at 6:05 p.m. or as soon thereafter as is practical to provide comment on the redistricting of the aldermanic districts of the City of Altoona as described on the official district map.

Due to Coronavirus COVID-19 Residents are encouraged to attend the Council Meeting via the application Zoom until further notice. ALSO TAKE NOTICE, that there has been introduced at a regular meeting of the Common Council, the following ordinance redistricting the boundaries of aldermanic districts. Said ordinance will be published twice, with this notice, prior to council action thereon. Introduction of said ordinance was within 60 days of an adjustment of ward boundaries pursuant to Sec. 5.15 of the Wisconsin Statutes. Adoption of the aldermanic district ordinance shall conform to Sec. 62.08 Wis. Stats.

ORDINANCE NO. 10C-21 **City of Altoona**

WHEREAS, Sec. 62.08 Wis. Stats., provides that the Altoona Common Council shall redistrict the boundaries of its aldermanic districts within 60 days after its ward boundaries have been readjusted as required by Sec. 5.15, and

WHEREAS, said ward boundaries have been readjusted as required by law, and a resolution was passed at the September 23, 2021, regular meeting of the Altoona Common Council, and

WHEREAS, Sec. 62.08 further specifies that all aldermanic districts must be as compact in area as possible and contain, as nearly as practicable by combining contiguous whole wards, an equal number of inhabitants according to the most recent decennial federal census of population, and

NOW, THEREFORE, the Common Council of the City of Altoona do ordain as follows:

PART I. The Aldermanic District Map established and maintained under the provisions of Ordinance 10C-21, is hereby repealed and recreated to readjust and relocate the boundaries of the City's six aldermanic districts as shown on the map attached hereto and incorporated herein by reference, and

PART II. The City of Altoona has prepared a plan for division of the City into wards, and for redistricting the aldermanic districts, all in accordance with said Tentative Supervisory District Plan, The Aldermanic District Map and Official Ward Map, exhibits to this Ordinance, will become effective after publication and apply to the 2022 Spring non-partisan elections and all elections thereafter until officially changed by the Common Council.

PART III. Repeal and recreate Chapter 2.12 of the Altoona Municipal Code "Wards and Aldermanic Districts". (1) First Aldermanic District, Wards 1 and 2; (2) Second Aldermanic District, Wards 3 & 6; (3) Third Aldermanic District, Wards 4 & 5; (4) Fourth Aldermanic District, Wards 7 & 8; (5) Fifth Aldermanic District, Wards 9 & 10; (6) Sixth Aldermanic District, Wards 11 & 12.
